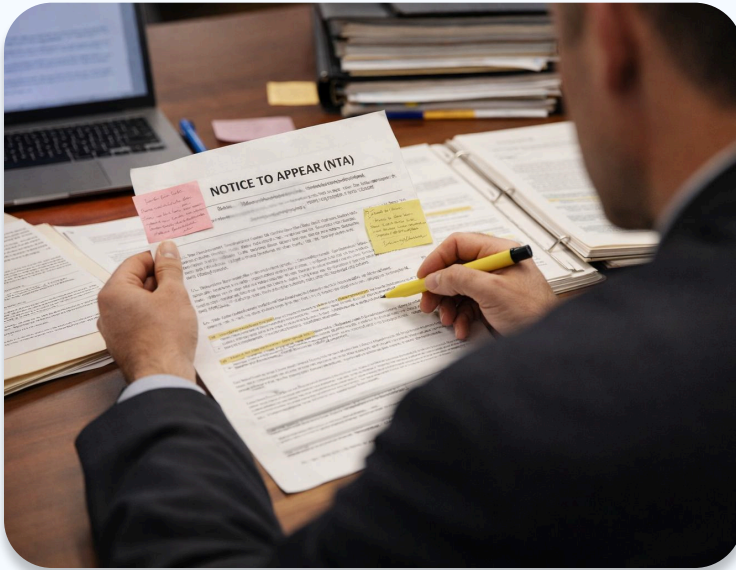
Introduction to Removal Proceedings Under INA §240

Removal proceedings under INA §240 form the procedural framework through which the government seeks to remove a noncitizen from the United States. These proceedings are conducted before the Executive Office for Immigration Review (EOIR) and are adversarial in nature, requiring careful procedural compliance and strategic planning by defense counsel.

At a high level, removal proceedings under INA §240 begin with the issuance of a Notice to Appear, followed by master calendar hearings and, where applicable, individual merits hearings. During these proceedings, the immigration court adjudicates both removability and eligibility for relief. If relief is denied, the process may conclude with the entry of a final order of removal, after which post-decision procedural options may be available depending on the case posture.

Common triggers for removal proceedings include criminal convictions, visa overstay, status violations, and allegations of fraud or misrepresentation. Understanding the statutory basis for removability allows attorneys to frame defenses accurately from the outset.





Understanding and Analyzing the Notice to Appear (NTA)

The Notice to Appear is the charging document in removal proceedings and must be analyzed carefully at the earliest stage. Effective review of a Notice to Appear requires verifying the accuracy of factual allegations and statutory charges, confirming proper service and filing, identifying defects or inconsistencies that may affect proceedings, and assessing whether jurisdiction has properly vested with the court. A disciplined and early NTA analysis supports issue spotting and helps attorneys determine whether procedural challenges may be appropriate.

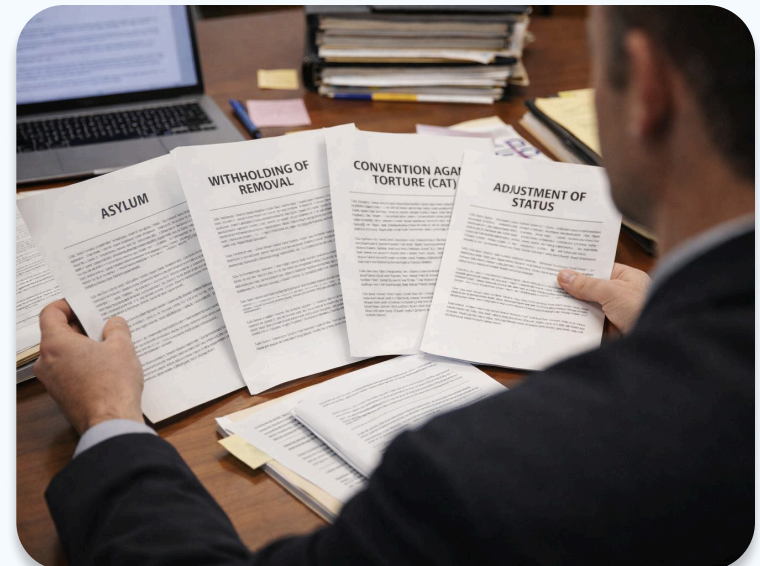
Defensive Applications and Forms of Relief

- ✓ Asylum, withholding of removal, and protection under the Convention Against Torture (CAT)
- ✓ Cancellation of removal for lawful permanent residents (LPRs) and non-lawful permanent residents (non-LPRs)
- ✓ Adjustment of status during removal proceedings, where statutorily permitted

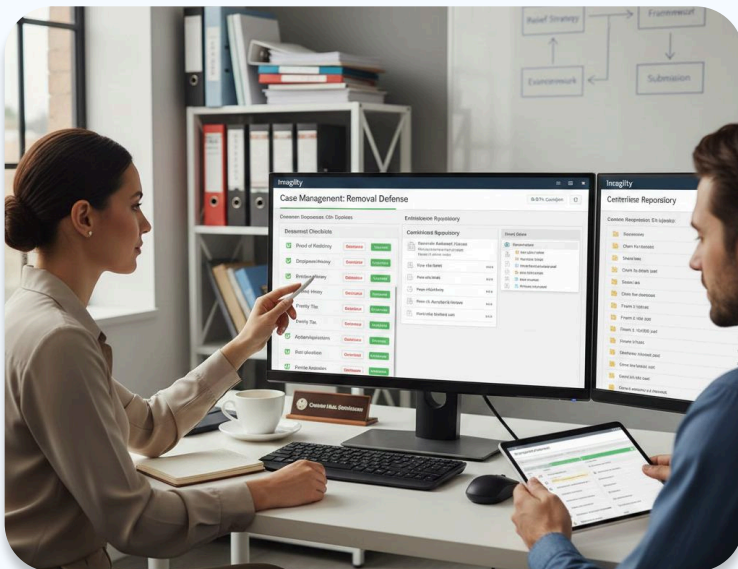


Evidence Collection and Document Management

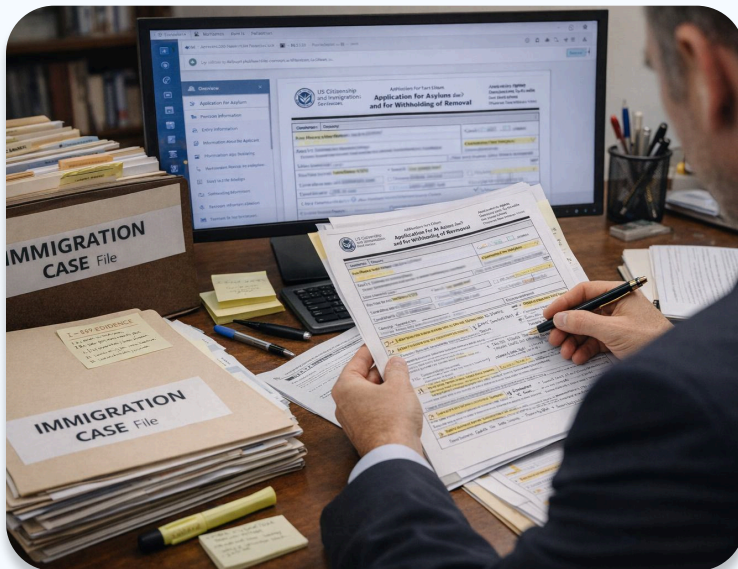
